As we embark on this journey of promoting undergraduate research, we reaffirm our commitment to excellence, integrity, and ethical conduct in all research endeavors. By equipping our students with the knowledge, skills, and opportunities to engage in meaningful research, we endeavor to prepare them for leadership roles in their respective fields and inspire them to make significant contributions to the advancement of knowledge and society.

In embracing the principles outlined in this policy, we uphold the core values of Dr. D.Y. Patil Vidyapeeth, Pune, and reaffirm our dedication to fostering a community of lifelong learners, critical thinkers, and responsible global citizens.

Objectives:

- Promoting Academic Excellence: To encourage students to engage in research activities
 that enhance their academic knowledge, critical thinking skills, and problem-solving
 abilities.
- **Fostering Innovation and Creativity:** To cultivate a culture of innovation and creativity among undergraduate students through hands-on research experiences.
- **Preparing Future Leaders:** To empower students with the necessary skills and competencies to become leaders in their respective fields by providing them with opportunities to undertake independent research projects.
- **Enhancing Faculty-Student Collaboration:** To facilitate collaboration between faculty members and undergraduate students, fostering a mentorship culture that supports research endeavors.

- Contributing to Knowledge Creation: To contribute to the advancement of knowledge in various disciplines through undergraduate research projects that address real-world problems and challenges.
- **Building credentials:** To build the credentials of undergraduate students through publication output, which will give them upper edge in higher education and placement.

Policy Guidelines:

- **Encouragement and Support:** The university shall actively encourage and support undergraduate students to participate in research activities, including but not limited to independent research projects, collaborative research with faculty members, and participation in research conferences and competitions.
- Access to Resources: The university shall provide undergraduate students with access to research facilities, equipment, and resources necessary to conduct their research projects effectively.
- **Financial support:** Seed money for research shall be made available through the Dr. D.Y. Patil Vidyapeeth Student Research Fellowship (DPU-STS) program, enabling students to initiate and pursue their research endeavors.
- Incentives: The undergraduate students shall be eligible for the publication incentives as per the rules and regulations laid down in the Research Policy Document of the Vidyapeeth.
- **Faculty Mentorship:** Faculty members shall serve as mentors to undergraduate students undertaking research projects, providing guidance, support, and expertise throughout the research process.
- Ethical Conduct: All research activities undertaken by undergraduate students shall adhere to the highest standards of ethical conduct, integrity, and professionalism. Students shall receive training in research ethics and responsible conduct of research.
- Dissemination of Findings: Students shall be encouraged to disseminate their research
 findings through presentations at conferences, publication in academic journals, and other
 appropriate platforms, thereby contributing to the broader academic community.
 Publication incentives shall be provided to undergraduate students as per the rules and
 regulations of the university, recognizing their contributions to scholarly dissemination.
- Recognition and Awards: The university shall recognize and reward outstanding achievements in undergraduate research through awards, certificates, and other forms of recognition, motivating students to excel in their research endeavors.
- Continuous Evaluation and Improvement: The effectiveness of the Undergraduate
 Research Promotion Policy shall be periodically evaluated and reviewed, with adjustments
 made as necessary to ensure its alignment with the evolving needs and priorities of the
 university and its stakeholders.

Implementation of Journal club to publication initiative:

- **First semester:** Creating a research group of Undergraduate students and presentation of one journal club on the topic of their interest.
- **Second semester:** Identification of research gap and its presentation in front of the internal experts. The identified research gap shall be enriched further by the concern faculty members.
- **Third Semester:** Allotment of Research mentor to each research group. Building of Research Proposal based on the research gap identified.
- **Fourth Semester:** Presentation of proposal by the students of obtaining scientific and ethics clearance and commencement of the experimental work and data collection.
- **Fifth Semester:** Data analysis by the undergraduate students followed by presentation of the data and approval from the mentoring faculty.
- Sixth semester: Manuscript writing and publication.

Implementation and monitoring:

The implementation of the Undergraduate Research Promotion Policy shall be overseen by the Research and Development Cell of the Vidyapeeth, in collaboration with Research and Development Cell of the Constituent Units. The policy shall be communicated to all stakeholders, including students, faculty members, and staff, through appropriate channels.

The Undergraduate Research Promotion Policy reflects Dr. D.Y. Patil Vidyapeeth, Pune's commitment to fostering a culture of research excellence and innovation among its undergraduate student community.
