

6. 5. 3: Impact Analysis Report

The Internal Quality Assurance Cell (IQAC) was established by DPU with the aim of promoting excellence through institutional quality parameters. Since then IQAC has contributed meaningfully for institutionalizing the quality assurance strategies and processes. This has helped in improving the academic, administrative and research performance as reflected in the achievements of DPU. Further the measures have been taken to improve the quality by internalising the quality culture based on core parameters of NAAC. The IQAC has been constituted as per the UGC and NAAC guidelines on 1st October 2009 as post accreditation initiative after the Vidyapeeth was accredited with 'A' grade by NAAC. The committee includes Vice-Chancellor as a Chairperson, external experts and members from constituent colleges/ institutes, students and administration.

Institution wise sub-committees have been formed with Principal / Dean / Director as the Chairperson and members from faculty. These sub-committees are responsible for implementation of quality enhancement activities within the framework of five core values given by NAAC. Further the IQAC collects all the information and data on academic, research, outreach and clinical activities along with the administrative actions for preparation of AQARs. The data and information received from all institutions is collected and verified by IQAC before being included in AQAR and other reports.

The impact of above initiatives:

A clear vision and mission with a focus on quality by a proactive leadership had enabled DPU to earn a place amongst the top-ranked Universities of the country. The IQAC monitors performance of constituent units by involving constituent unit based Sub-committees which conduct awareness and sensitisation activities that are documented and reported to IQAC. These Sub-Committees also help IQAC to conduct impact analysis for which both qualitative and quantitative data are used.

Feedback taken from students, teachers, institutional heads, parents and alumni is used for impact analysis and for implementing quality enhancement initiatives. Inputs from external agencies e.g. NAAC, NABH, NABL, all Regulatory Councils like MCI, DCI, AYUSH, INC, UGC, AICTE, DBT, SIRO, BIRAC and others (AAA, ISO) are also used for quality enhancement.

This has enabled DPU for its holistic development in the last five years. The improvement in the performance and some quality audits conducted as well as the achievements are as follows:

1] Improvement in the performance:

- DR. D.Y. Patil Vidyapeeth was accorded Category I University status by University Grants Commission under Graded Autonomy 2018.
- Inclusion of the DR. D.Y. Patil Vidyapeeth under Section 12B by the University Grants Commission in 2018.
- The Vidyapeeth achieved 9th rank amongst the cleanest Higher Educational Institutes in the country in the Category of Residential Universities UGC in Swachh Campus Ranking 2019 conducted by MHRD, Government of India.
- The Constituent units increased from 7 to 9 with inclusion of Ayurved and Homeopathic Medical Colleges under the ambit of DPU
- In all 22 PG programmes were added (Ayurved, Homeopathy, Emergency Medicine)
- There is increase in academic departments from 39 to 68 (87.1%),
- New programs have been increased from 73 to 119 (46.6%)

- Three new super speciality programs were added viz. DM-Cardiology, MCH CVTS and DM Neurology.
- Average number of days for declaration of results improved to less than ten days (av.5-7.5 days)
- New courses have increased from 583 to 832 (42.7%) and value added courses from 29 to 79.
- About 81% curricula were revised.

- The student strength has increased from 3310 to 4826
- Total teaching staff increased from 501 to 642.
- The infrastructure was expanded and hospital beds were increased from 1480 in 2014 to 2011 in 2019.
- State of the Art Eighteen (18) Modular OT's were added with Robotic Surgery facility and Renal Transplant, Liver and Corneal Transplant were started.
- Human Milk Bank was upgraded to international standards.
- Dental Implant Centre was established.
- DPU Incubation Centre was established and 14 patents have been published, 5 patents have been filed and 1 US patent is granted.
- Medical Hospital Building has been Completed with 8 Floors.
- State -of-the-art CSSD facility is created.
- Internet Band width is increased to more than 1000 Mbps.
- Number of smart boards increased from 7 to 33.
- Number of CCTV increased from 228 to 688.
- Number of PCs increased from 860 to 1669.
- New auditorium and New Vidyapeeth office have been constructed.
- Central Library is upgraded with state of the art facilities.

• Teaching-learning infrastructure was augmented with ICT to develop smart classrooms for interactivity. Expected Learning outcomes are available to students through the DPU-ERP as also e-lectures and videos, developed by faculty. These enhancements are supported by continuous assessment, online self-assessment and examinations.

• For e-content development facilities like Media Centre and Lecture recording are created. In order to include e-content in learning DPU has developed AV studio that is used for learning innovations.

• These initiatives have shown enhancement in student performance as reflected in curriculum outcome analysis by the examination scores and pass percentage (avg. 95%), which has shown an upward trend in the last five years.

• Impact of research promotion initiatives and efforts to promote research have made a significant impact that includes:

• Establishment of Regenerative Medicine and Molecular Diagnostic Laboratories, DPU Incubation Centre and provision of seed money (Rs. 407.81 lakh) to 380 teachers have resulted in start-ups incubated on campus, award of 20 Patents and Copyrights, increase in publications from 1631 (2009-14) to 1910 (2014–19). Increase in publications in indexed journals from 1240 (2009-14) to 1619 (2014–2019), publications in high impact factor journals like Nature and Lancet, 3686 citations in Scopus and increase in h-Index of 24 to 47 (Scopus) overall and generation Rs. 136.59 lakh from research consultancy.

• DPU-ERP provides online administrative support and has structured feedback mechanisms to collect and analyse data. Students assess curricular aspects, quality of teaching-learning process, mentoring support and utilisation of upgraded facilities. Faculty feedback is solicited on work satisfaction, teaching-learning process, student progress and research. Feedback is used to make necessary improvements.

• Administrative and financial management of DPU follows a continuous quality improvement policy with maximum transparency and meticulous documentation. Significant progress has been made towards achieving paperless administration. In-house DPU-ERP has made services efficient for patients, students, faculty and staff.

2] Participation in Accreditation process :

The continuous and sustained development has enabled DPU to undergo accreditation by National Assessment and Accreditation Council (NAAC) for two consecutive cycles in 2009 and 2014 and was accredited with A grade with CGPA of 3.08 and 3.62 respectively.

• During the first cycle of accreditation the Peer Team visited Dr. D. Y. Patil Vidyapeeth, Pune from 7 to 9^{th} April 2009. The team submitted the report of their observations (<u>View Document</u>). The action taken report on recommendations of the team (2009) is submitted to NAAC in the SSR 2014 of 2^{nd} Cycle. (<u>View Document</u>).

• The second cycle of accreditation was conducted in January 2015 and the peer team report has been submitted (<u>View Document</u>) to NAAC. The action taken report on recommendations of NAAC peer team (2015) is prepared.(<u>View Document</u>)

• Participation in pilot study project of NAAC after the release of new manual for the Health Sciences Universities in 2019.

3] Quality audits: AAA visits and AQARs

During the period under assessment (2014-15 to 2018-19) two AAA visits were conducted by involving experts from field of health science education. The details of visit schedules are as follows:

4] Participation for NIRF process :

DPU has actively participated in the National Institutional Ranking Framework (NIRF) process with the IQAC acting as a nodal point for data and document collection and analysis. As a result of these sustained efforts, DPU has been able to

achieve a high rank consistently in the NIRF. The details of year wise achievements of DPU in National Institutional Ranking Framework (NIRF) conducted by Ministry of Human Resource Development (MHRD), New Delhi, are as follows:

- NIRF-2020 : Dr. D. Y. Patil Vidyapeeth, Pune has achieved rank as 3rd in Dental Category, 24th in Medical Category, 46th in University Category and 75th in Overall Category in India.
- NIRF-2019 : Dr. D. Y. Patil Vidyapeeth, Pune has achieved rank as 20th in Medical Category, 46th in University Category and 70th in Overall Category in India.
- NIRF-2018 : Dr. D. Y. Patil Vidyapeeth, Pune has achieved rank as 18th in Medical Category, 52nd in University Category and 79th in Overall Category in India.
- NIRF-2017 : Dr. D. Y. Patil Vidyapeeth, Pune has achieved rank as 47th in University Category and 76th in Overall Category in India.

After completion of 5 years (2014-15 to 2018-19) DPU is now going ahead with the 3rd cycle of reassessment by NAAC as per the Manual of Health Sciences for Universities revised on 23/9/2019. During this period of five years the IQAC has taken several initiatives for enhancement of quality of teaching-learning, research, training, cocurricular and extracurricular activities of DPU. IQAC has contributed significantly for institutionalizing the quality assurance strategies and processes by forming various committees like Anti-Ragging Committee, Grievance Redressal Cell, Website Committee, Parents Teachers Meeting Committee and Mentorship Committee. 
