Standard Operating Procedure (SOP) for

University Centre for Professional Education and Faculty Development (UCPE & FD)

WHEREAS Dr. D. Y. Patil Vidyapeeth, Pimpri, Pune popularly known as "DPU", managed by Dr. D. Y. Patil Vidyapeeth Society, Pune, was declared as "Deemed-to-be-University", under Section 3 of UGC Act 1956 in 2003.

AND WHEREAS today the Vidyapeeth has 14 constituent institutions under its umbrella. All the institutions have the approval / recognition of the relevant statutory bodies to offer UG, PG Degree, Super-specialty and Ph.D. programmes in relevant and emerging disciplines, specializations and super specializations.

AND WHEREAS, as per the provisions of University Grants Commission (Institution Deemed to be University) Regulations, 2019 in Sub Clause Nos. 10.07 sub-sub clauses 10.07.1 and 10.07.2 provides that the Board of Management shall be the Principal Organ of Management and the Apex Executive Body of the Institution Deemed to be University, with powers to make rules and shall be the final decision-making body in respect of every matter including academic, administrative, personnel, financial, development matters of institution Deemed to be Universities.

AND WHEREAS, as per the provisions of University Grants Commission (Institution Deemed to be University) Regulations, 2023 Clause 11 and Sub Clause No. 11 (3) and 11 (4), Clause 13 and Sub Clause No. 13 (1) and 13 (2) of the Regulations provides that the Executive Council shall be the Principal Organ of Management and the Apex Executive Body of the Institution Deemed to be University, with powers to make rules and shall be the final decision making body in respect of every matter including academic, administrative, personnel, financial, development matters of institution Deemed to be University.

AND WHEREAS, after careful evaluation of various strategies to advance faculty development, and in line with the commitment to standardize and unify practices across all constituent units of Dr. D. Y. Patil Vidyapeeth, Pune (Deemed to be University), the University has resolved to implement this SOP for the University Centre for Professional Education and Faculty Development (UCPE & FD). All Constituent Colleges and Institutes shall adhere to the processes outlined herein to promote excellence in faculty development and health professions' education, thereby ensuring continuous quality enhancement in teaching-learning and the achievement of intended learning outcomes at both Programme and Course levels. The SOP is being amended to incorporate recent academic advancements and evolving institutional needs and shall remain effective until amended or superseded by further notification from the University.

INTRODUCTION

This Standard Operating Procedure (SOP) establishes a structured framework to ensure uniformity and standardization in the planning, design, implementation, and evaluation of faculty development initiatives across all constituent units of Dr. D. Y. Patil Vidyapeeth, Pune. It serves as a guiding document to foster academic excellence by enhancing the pedagogical, research, and professional competencies of the faculty.

The SOP is applicable to all constituent colleges/institutes and facilitates alignment with institutional goals, regulatory requirements, and global best practices in faculty development. It further outlines the procedure for identifying training needs, executing focused development programs, and assessing the impact on educational quality and learning outcomes.

VISION:


To achieve educational excellence through faculty development in health professions and higher education, ensuring an empowered, skilled, and future-ready academic workforce.

MISSION:


To continuously enhance the academic and professional competencies of faculty as educators, researchers, and leaders by delivering structured, innovative, and impactful faculty development programs.

- To establish a continuous cycle of training needs analysis, implementation, and impact assessment for quality improvement.







RESPONSIBILITIES:

The Director, UCPE&FD at the University and the Heads of respective Constituent Units are respectively responsible for ensuring effective implementation of the SOP.

IMPLEMENTATION:

- UCPE & FD shall function through a dedicated committee with representation from Education Units, IQAC, and Research Directorate.
- Each Education Unit shall conduct annual training needs assessments and develop 6-monthly FDP calendars.
- Programs shall be designed based on institutional requirements, regulatory guidelines (UGC, NAAC, NMC), and global benchmarks.
- Administrative and academic training shall be coordinated in collaboration with HR Cells.
- A 5-Year Strategic Plan shall be developed, including budget and resource planning, based on multi-stakeholder feedback.
- An annual report shall be compiled encompassing all development activities across the university.
