Value Added Programmes / Short Term Training Programme / Certificate and Fellowship Programmes.

WHEREAS, the UNIVERSITY GRANTS COMMISSION, (Institution s Deemed to be Universities) Regulation 2019, (herein after in this SOP referred as Regulations) has been published in the Gazette Notification of India by the Authority, University Grants Commission.

AND WHEREAS, as per the Provisions of University Grant's Commission (Institutions Deemed to be Universities) Regulations, 2019 in Clause Nos. 10.11.2(i) which contains, the Planning and Monitoring Board is responsible for the monitoring of the development programmes and (v) the recommendations of the Planning and Monitoring Board shall be placed before the Board of Management for consideration and approval.

AND WHEREAS, as per the Provisions of University Grants Commission (Institutions Deemed to be Universities) Regulations, 2019 in Clause Nos. 10.11.4 (i) and , Clause No. 1.7.3 (i), (iii), (iv) and (vii) of the Bye Laws of the Dr. D. Y. Patil Vidyapeeth Pune, the Board of Studies to recommend to the Academic Council for its approval, the introduction in the syllabi of the courses of study.

AND WHEREAS, as per the Provisions of Bye Laws of the Vidyapeeth in Clause No. 1.6.5 (iv) Faculties to consider and recommend to the Academic Council establishment of new Courses, Inter-disciplinary Courses and training programmes, recommended to it by the Board of Studies.

AND WHEREAS, as per the Provisions of University Grants Commission (Institutions Deemed to be University) Regulations, 2019 in Clause Nos. 10.11.1 (B-iv) which contains, the Academic Council to prescribe courses/programmes of study leading to degree and diploma of the Institution Deemed to University to the Board of Management.

AND WHEREAS, as per the Provision's of University Grants Commission (Institutions Deemed to be University) Regulations, 2019 Sub Clause No. 10.07 and its sub—sub clause no. 10.07.1 and 10.07.2 of the Regulation provides that the Board of Management shall be the principal organ of management and the apex executive body of the institution deemed to be university, with powers to make rules and shall be the final decision making body in respect of every matter including academic, administrative, personnel, financial and development matters of institution deemed to be University.

AND WHEREAS, making of such provisions enabling the constituent units of the Dr. D.Y. Patil Vidyapeeth ensures that every individual inside the campus exercise these regulations.

OBJECTIVES

- 1. To promote and nurture talent
- 2. The introduced new programmes in the frontier areas of Knowledge to the Students.
- **3.** To provide an opportunity to the deserving candidates to undertake advance studies and research.
- **4.** To encourage the students to attend more training, certificate and fellowship programmes to enhance their skill.

ACADEMIC REGULATIONS OF THE PROGRAMME

VALUE ADDED PROGRAMME / SHORT TERM TRAINING PROGRAMME

Value Added Programme (VAD) / Short Term Training Programme (STTP) shall be offered by the Institutions / Depts. / Colleges concerned and certified and documented by the Institution Heads and Head of the Department, which shall be countersigned by the Registrar of the Vidyapeeth They will announce Academic Calendar and Time Table. However, the Head of the Departments / Head of the Institutions shall take permission from the Vidyapeeth every year for offering the same.

The VAD/STTP shall be of 2-3 days duration and shall have minimum of 16 hours and maximum of 24 hours of Teaching, Learning and Training (7 0 % practical, demonstration, hands on experience and 30 % theory, assignments and group discussion). (Equivalent to one to two credits) Value Added Programmes can be offered to UG/PG student as well as others who are eligible for the same.

CERTIFICATE PROGRAMME

Certificate courses can be offered based on the eligibility criteria approved by the Board of Management, for a given Programme. The Certificate Programmes shall be of minimum 6 months duration plus additional four hours ends on after one week having 12 0 teaching and working days and the programme must have minimum 480 hours of Teaching, Learning (equivalent to around 20 credits)

180 hours of Practical, Hands on Experience And Demonstration /Lab work	6 Credits
180 hours Field Work / Clinical Work / Research Projects	6 Credits

FELLOWSHIP PROGRAMME

Fellowship Programme shall be offered only to Postgraduate Degree holde rs of the subjects concerned. The Fellowship Programme shall be of one year with 240 teaching and working days / 2 semesters with the following distribution.

The Programme shall have the contents of around 960 hours of Teaching, Learning (around 40 Credits) (Each semester may have 20 Credits \pm 4 Credits)

150 hours of Teaching and Learning	10 Credits
90 hours of Assignment / Seminar / Group Discussion/ Tutorials	6 Credits
360 hours of Practical / Demonstration / Hands On Experience / Lab Work	12 Credits
360 hours of Field Work / Clinical Work / Research Work	12 Credits

INSTRUCTIONS

- 1. Value Added Programmes (VAD) / Short Term Training Programmes (STTP) (more than 15 hours) / shall be offered by the Institutions/ Departments/ Centre Concerned and certified and documented by the Institutions heads and Head of the Departments. However, the Head of the Departments / Head of the Institutions shall take permission from the Vidyapeeth every year for offering the same.
- 2. The Fellowship / Certificate programmes (Where the duration is 6 months and beyond) shall be offered by the Head of the Departments, Head of the Institutions which is duly approved by the Academic Council and Board of Management. The Academic Calendar shall be issued by the Head of the Institutions. Timetable, Documentation and Course / Programme shall be issued by the Head of the Departments / Head of the Institutions. The examination shall be conducted and certified by the Head of the Departments / Head of the Institutions, for Courses above 6 months duration.
- **3.** The duration and time as well as teaching learning hours specified are minimum requirement.
- **4.** Fellowship Programme (One-year duration with 240 days of teaching days) shall be offered only to Postgraduate Degree holders of the subjects concerned.
- **5.** Value Added Programmes can be offered to UG/PG students as well as others who are eligible for the same.
- **6.** Certificate courses can be offered based on the eligibility criteria fixed by Vidyapeeth for a given Programme and approved by the Board of Management.
- 7. Trimester means 3 months with 60 days of teaching work. Semester means 120 days of Teaching work in 6 calendar months. One year means 240 teaching days in 12 calendar months.
- **8.** Under Value Added Programme, depending upon the nature of study, the duration can be extended.

C) EXAMINATION, EVALUATION AND DECLARATION OF RESULT EXAMINATION METHODS / SCHEME

- 1. For Value Added Programme, the Head of the Institutions and Coordinators may decide the methods of Examination and Evaluation. The outcome would be "Successfully completed the Value Added Programme" or "Not successful in Value Added Programme" and Certification.
- 2. For STTP there can be a Theory Paper of 30 marks and a Practical cum Viva Voce for 70 marks (Total: 100 marks). Minimum for passing will be 50 % in each i.e T and P and aggregate of 50 %.
- 3. For Certificate Programme of 6 months, there can be one Theory Paper for 60 marks and a Practical and Viva voce for 140 marks (Total: 200 marks). Pass percentage is 50 % in each i.e. Theory and Practical and in aggregate.
- 4. For Fellowship Programme of one year, there can be 2 Theory Papers of 60 marks each and one Practical and Viva voce of 280 marks, a total of 400 marks. Pass percentage is 50 % in Theory /Practical and 50 % in aggregate.
- 5. The Head of the Departments shall maintain all the records.
- 6. The marks card and passing certificate will be issued for the Certificate/ Fellowship / Diploma Programmes, by the Head of the Institutions with the signature of course co-coordinator, Head of the Departments, Head of the Institutions and endorsed by the Registrar of the Vidyapeeth.

D) PROCEDURE FOR COMMENCEMENT OF THE PROGRAMME IS AS FOLLOWS:

- 1. Title of the Programme, Programme objectives, year and date of implementation.
- 2. Eligibility for the Programme (To whom it is offered) and format of Application form.
- 3. Duration of the Programme.
- 4. Content / Syllabus of the Programme (unitized with specified hours/ as per Academic Regulations)
 - Number of papers (title) Theory / Assignments / Seminars/Group Discussion.
 - Number of Practical (title), Demonstration and Hands on Experience.
 - Field work / Clinical Work/ Research Project
 - ❖ Minimum number of hours of Teaching, learning for each unit shall be as per the prescribed hours given in the instructions/ Academic Regulations. Head of the Institutions may enhance or reduce them 10-15 % as per the need.

- 5. Curriculum Delivery/ Transaction (Teaching, Learning of content)
- 6. Programme outcome (Expected)
- 7. Examination and Evaluation methods (Maximum Marks and Minimum Marks or Grade for Passing), Evaluation Authority and duration of Examination. (T/P/A)
- 8. Certification Authority and Design of Certificate.
- 9. Place and Venue of the Academic work of the Programme.
- 10. Department and Institute offering the programme and overall coordination. Intake per batch, Academic Calendar, Timetable, Main tenance of Attendance, arrangements and conduction of the programme, Liasoning, evaluation, documentation, Feedback, certification and other admission aspects/ Appointment of Director/ Coordinator/ Resource persons Teachers and Assistance.
- 11. Approximate Expenditure involved running one batch per a programme.
- 12. Nominal fees proposed to be charged per course per participant w ith the approval of authorities.
- 13. Financial and Administrative Expectations from the DPU to run the programme.
- 14. Infrastructure Requirements Class rooms/Practical Halls/ Hospital / Clinical / PHC/Any other.
- 15. Yearly Financial Audit process and format.
- 16. Annual Meta Evaluation and up gradation of the content and delivery of the programme.
- 17. Central Documentation
- 18. Grievance Redressal and Appeals Mechanism
- 19. Any other Aspects of the programme not covered above.
- 20. Saving clause whenever difficulty arises powers of the authorities of the Vidyapeeth.

Grievance Redressal and Appeals Mechanism

In case if there is any dispute arises regarding the above mentioned programmes regarding admission or any other dispute concerned with above mentioned, the Grievance Redressal Committee of the concerned Institute/College shall examine the matter after hea ring both the parties and report has to be submitted to the Vidyapeeth.
